### Bloomington Convention and Visitors Bureau's 2014 Stick & Stay Sweepstakes

#### **Official Rules**

### NO PURCHASE NECESSARY TO ENTER OR WIN.

- 1. **SWEEPSTAKES DESCRIPTION**: "The Bloomington Convention & Visitors Bureau's Stick & Stay Sweepstakes" (the "Sweepstakes") will begin on Monday, June 2, 2014 at 9 am Central Standard Time ("CST") and concludes on Friday, August 22, 2014 at 11:59 p.m. CDT (the "Sweepstakes Period"). The Sweepstakes is sponsored by the Bloomington Convention and Visitors Bureau (the "Sweepstakes Sponsor").
- 2. ELIGIBILITY: The Sweepstakes is open to legal residents of the fifty (50) United States and District of Columbia and to all legal residents of Canada, who are at least the age of majority in their state/province of primary residence as of the first day of the Sweepstakes Period. Notwithstanding the above, the Sweepstakes is not open to individuals associated with the Sweepstakes, including the employees, agents or representatives of the Sweepstakes Sponsor (including its respective divisions, subsidiaries, affiliates and advertising or promotional agencies) and suppliers providing prizes or other materials or services in connection with this Sweepstakes (collectively, the "Excluded Individuals"). - 3. **HOW TO ENTER:** Go to www.bloomingtonmn.org/StickandStay ("Sweepstakes Website") and follow the online instructions to access the entry form.

On the entry form, you will be required to provide the following: first name, last name, email address, zip code, and country. You must be 18 in order to win this sweepstakes.

Only one (1) entry per household per day will be accepted during the Sweepstakes Period. For purposes of these Official Rules, a "day" is defined as any time period during the Sweepstakes Period beginning each day at 12:00 a.m. CST and ending each day at 11:59 p.m. CST. Entries received in excess of the stated limitation will be void. The Sweepstakes Sponsor will not accept entries by phone, mail, email, fax or any other method not specifically permitted herein or if not received during the Sweepstakes Period. This sweepstakes is in no way sponsored, endorsed, administered by, or associated with Facebook. By entering, you understand that you are providing your information to Sponsor(s) and not Facebook.

- **RANDOM DRAWING:** Following the end of the Sweepstakes Period on August 22, 2014, seven (7) potential winners will be randomly selected from among all eligible entries received during the Sweepstakes Period. In order to be declared one of the winners by the Sweepstakes judges, a potential winner must be in compliance with these Official Rules and, in particular, the following:
- a. - 20. In the event of any dispute, all parties agree that the judgment and determination of the Sweepstakes Sponsor or its representatives will be final and binding in the awarding of the Prize.
- 21. The words importing the masculine gender shall include the feminine gender and vice versa in both the singular and the plural.
